Specific Objectives

- 1. To identify and select the best-good practices in evaluation from Western Balkan countries , and
- To discuss and establish the high level of evaluation standards by WBEN (accepted by VOPEs members) as benchmarks for stringer VOPEs and individual evaluators in the region.



Four Activity Clusters

- 1. Establishing cooperation between **VOPE and national evaluation** authority..
- 2. Identification of good practice in policy evaluation on national level, organization of event for presentation of collected best practices select by project partners. The five good practices from each country will be presented on WBEN regional meetings.
- 3. <u>Organization of WBEN regional meetings</u> with two thematic topics: presentation of best practices from four WB countries and the most effective tools for dissemination and experience exchange as well as criteria for establishing evaluation standards on regional level.
- 4. Preparation and publishing the project results (brochure with best practices, <u>criteria for evaluation standards and procedures for accreditation of VOPEs)</u>

Expected results

- 1. Established 4 (four) partnerships on national level for cooperation between VOPE and national authority body for evaluation;
- 2. Organization of 4 events for presentation of national best practices in evaluation;
- 3. Organization of WBEN regional meetings for regional best practices in evaluation and select 20 of them (5 from each VOPEs).
- 4. Printed brochure with all presented best practices
- 5. Developed criteria for regional credentials for individual evaluators from WB Countries
